

AIM Korea

- Korea's AIDC market is considered to be relatively less affected by covid-19 compared to other industries.
- In some cases, the demand for non-face-to-face work and daily life and automated logistics systems is rather booming.
- However, AIDC hardware manufacturers are not meeting the proper delivery due to semiconductor production setbacks and international logistics restrictions.
- AIM Korea is in a situation where there are not many activities due to non-face-to-face quarantine rules.
- The chairperson of AIM Korea was transferred to the new president after two years of tenure.
- The Secretary General will continue to work. Business continued as before without any special issues.



AIM India

- 1. After series of COVID-19 lock downs, life is limping back to normalcy. Last Lockdown opened on 24th Jan '22. Businesses have been severely affected. But going forward the businesses are picking up.
- 2. Currently the AIDC market is suffering from acute shortage of Hardware with long delivery time.
- 3. First meeting of the proposed members of AIM INDIA was held on 18th Dec 2021.
 - a. Receipt of approval from AIM Global was announced
 - b. Suggestions on the making of AIM INDIA were discussed and making Section8 Company was agreed by general consensus.
- 4. Name AIM INDIA has been approved by the Ministry of Corporate Affairs, Government of India
- 5. Application under finalisation for Ministry of Corporate Affairs, Government of India for getting the Company registered and getting a licence.
- 6. Once the Company has been registered, we would be able to open a bank account and collect subscription money. After that AIM INDIA will become operational in full earnest.
