FSMA 204: Enhanced Traceability Recordkeeping Requirements



Enhanced Traceability

FSMA 204 lays the foundation for end-to-end food traceability, extending beyond the current "one-up and one-back" requirement.



Designated High-Risk Foods

Listing of a wide variety of produce, dairy, seafood, and ready-to-eat products that would require traceability records.



Harmonized Approach

Reviewed existing standards, industry initiatives and current approaches.

Who is Affected?

Proposal is a requirement for those who:

- Manufacture
- Process
- Pack or
- Hold foods on the Food Traceability List (FTL)

The additional recordkeeping requirements would apply not only to foods specifically listed on the FTL, but also to foods that contain foods on the list as ingredients.

Includes domestic and foreign entities









Making Sense of the Data

It's all about Events and Attributes

Critical Tracking Events (CTE)

An event in the supply chain of a food involving the growing, receiving (including receipt by a first receiver), transforming, creating, or shipping of the food.

Key Data Elements (KDE)

The data attributes or information associated with a Critical Tracking Event for which a record would have to be established and maintained.

Peanut Butter and Peanut Butter Crackers (No kill step)





Proposal Aims to Help the Food Industry









Standardize

Data elements and information that companies must establish and maintain across the supply chain.

Define

Define the information to be shared with the next entity in the supply chain.

Facilitate

Rapid and accurate traceability capture required traceability data.

Act

Leverage traceability data needed to prevent or mitigate foodborne illness outbreaks.



GS1 US EPC Extended Attributes Group

Charter Statement: "Working within the GS1 system of standards, simplify the capture of traceability attributes encoded in the EPC/RFID data carrier in the Foodservice and Retail Grocery industries."

Scope: "This workgroup will fully define the problem and business requirements, weigh possible solutions, and create an industry-specific guideline that defines near-term guidance in a manner that will not hinder the community or industry."
